RE: Response to 2022-10 USDOT IMPO Certification Review Transmittal Letter

Mr. Hannon and Ms. Brookins,

As stated in the Certification Review Transmittal Letter, the Indianapolis Metropolitan Planning Organization (IMPO) was tasked with developing a sustainable plan of action for the following Corrective Action: "FHWA and FTA determined that the IMPO has not demonstrated consultation with the environmental resource agencies in the transportation planning process and does not meet the requirements outlined in 23 CFR 450.324 (f) (10)."

The IMPO's plan of action is as follows:

- The IMPO will be issuing a Request for Proposals for a major Metropolitan Transportation Plan (MTP) update (aka. 2050 MTP v2) in January 2023. The expected kick-off for that project will be May 2023 and is expected to be an 18-month update. As part of this major MTP update, the following tasks will be included:
 - a. The IMPO will invite representatives of the "Environmental Interest Parties" and "Interagency Consultation Group Parties", as listed in the attachment to this letter, to be part of the 2050 MTP v2 Project Consultation/Steering Committee. Agencies who participate on the committee will contribute to brainstorming, review drafts, and attend meetings to engage in discussion on the contents and direction of the MTP.
 - b. The 2050 MTP v2 will include references to the Red Flag Investigation processes and potential mitigation measures. References will also be made to State NEPA processes (as applicable under the IMPO's Federal Funds Exchange program).
 - c. The 2050 MTP v2 (including an expansion of the preferred regional land use scenario) will include discussions of environmental factors throughout the region including farmland,

water bodies, floodplains, parks/greenways, and VRP/Superfund sites. The 2050 MTP v2 will also include an analysis of wetlands, streams/riparian corridors, reservoirs, historic sites, endangered species, etc. These factors will also be discussed in connection with documentation and mitigation requirements of State NEPA processes.

- i. The IMPO may consider environmental factors in selection of projects, while respecting already-established mitigation requirements.
- 2. For the current version of the 2050 MTP, which will remain active until the MTP major update is complete, the following tasks will be included:
 - a. The IMPO will directly notify representatives of the "Environmental Interest Parties" and "Interagency Consultation Group Parties", as listed in the attachment to this letter, of comment periods for all MTP proposed amendments and consultation will be documented in an appendix of the MTP.
